AWARD CRITERIA

STEP 1: Do You Qualify?

The recipient of the award must be an Active SCWBEC Member and comply with all the following criteria:

- She alone, or together with one or more women, must own 51% interest of the business.
- 2. The business must be operational for a minimum of one year.
- She is involved with day-to-day operations and plays a major role in policy making for the company.
- The applicant's business and residence must be located on Long Island, NY.
- The business must be a "for profit" company.
- The applicant must be an active member of SCWBEC. *
- Applicant has not received this award in the past for the same business and/or industry classification.
- 8. Applicant is not actively serving on SCWBEC Board of Directors.
- Recipient agrees to purchase Holiday Breakfast Event Ticket to receive the award.
- 10. Recipient agrees to give a presentation on the use of the award at a SCWBEC meeting within 3 months of receipt and provide a written description on the use of the award within 6 months of receipt for our website.
- * Active Membership requires signed-in attendance at three qualifying meetings/events in the six months prior to the application submission.

- 1. Proof of 51% Woman-Owned Business: Examples: A copy of the Business Certificate, Certificate of Organization, IRS Form 1099, Shareholder Log, or Form Schedule C or K-1.
- 2. A recent business tax return or current year-to-date P&L statement.
- 3. Description of the products or services offered by your company.
- 4. What is your niche? How are you different from your competition?
- 5. What will you use the award money for? Describe and breakdown in detail.
- 6. How will this award grow your business?
- 7. What is your experience in this business/field? List any degrees/certification you have attained.
- 8. The industry/sector the business serves.
- 9. Is there anything else the committee should consider?
- 10. A completed Form W-9. (Available at irs.gov)
